Hello,

The chapter has the following vacancies:

- President - vacant as of March 25* with the resignation of Susan McCourt. *NOTE: MCCC Director, Catherine Adamowicz, has agreed to serve as interim.
- Vice President - vacant as of March 25 with the resignation of Sandy Lygren.
- Secretary - will be vacant as of May 31 with the resignation of Martha Ucci.

Therefore, the Chapter is **seeking nominations** for President, Vice President, and Secretary to finish the terms (June 1, 2019 - May 31, 2020).

Per the BrCCC bylaws, Article IV:

1. The President shall:
 1. preside at meetings of the Executive Committee and membership;
 2. serve as co-chair of the Management Association Committee on Employee Relations (hereinafter MACER);
 3. appoint the chair and members of the standing committees, other committees or teams, and representatives of the BrCCC on committees formed under the collective bargaining agreement or by the administration of the college;
 4. be an ex officio member of all committees except the Nominations and Elections Committee;
 5. represent the chapter as a delegate to the MCCC Delegate Assembly.
2. The Vice President shall:
 1. preside at meetings of the Executive Committee and membership in the absence of the President;
 2. assume the duties of the President in case of the death, resignation, retirement, or recall of the President or in the event the President is unable to perform the duties of that office;
 3. represent the chapter as a delegate to the MCCC Delegate Assembly.
3. The Secretary shall:
 1. keep minutes of the meetings of the Executive Committee and the membership;
 2. maintain official records and assist the President with the Association's communications;
 3. represent the chapter as a delegate to the MCCC Delegate Assembly.

There are stipends and/or reassigned time for these positions.

There is a **special meeting** planned for **April 10 at 2-3 pm in E-203** in Fall River to help members understand the purpose of the union and the roles of the union leadership. You are encouraged to attend this meeting especially if you are at all interested in serving your union.

Nominations open April 1 and close at 11:59 pm on April 14. Nominees will be announced April 15 via email. An online election will open May 1 and close at 11:59 pm on May 10. In the event that all

positions have one or fewer nominees, then the new officers can be elected by motion at the next Chapter Meeting on April 22 and an online election will not take place.
